Any cost for said trainings shall be paid for by Basham. If Basham fails to satisfy any portion of this condition, Certificate Number 201084483 shall not be reinstated until such condition is satisfied.

Upon reinstatement of Certificate 201084483, Certificate Number 201084483, and any future endorsements or new areas of certification, shall be subject to the following probationary conditions for five (5) years:
