SPECIAL MEETING

The purpose of this meeting was for the JCPS Superintendent Search Advisory Committee members to collaborate to shape the vision and criteria for the next superintendent and review and make recommendations regarding the superintendent selection process.

I. Call to Order

The meeting began at 5:00 p.m.

II. Welcome and Expectations

Board of Education Chairman Corrie Shull convened the meeting, provided a brief overview of the meeting's objectives, and opened the floor for questions from members.

III. Introduction of Members

Committee members engaged in a round of introductions, each sharing their name and any organizations they represented. Dr. Shull announced that Debbie Wesslund would be the chairperson and he would be assisting her.

IV. Initial Discussion of Superintendent Qualities and Attributes, and Make Recommendations to the Parent Survey to be Distributed

Committee members were invited to identify key qualities and characteristics they deemed essential for the next Superintendent. To facilitate this process, each member utilized a word cloud generator. This tool visually represented the frequency of words, with larger and bolder text indicating more frequent mentions. Analysis of the word cloud revealed that 'collaborative,' 'innovative,' 'compassionate,' 'integrity,' 'balance,' and 'visionary' were among the most frequently emphasized qualities.

Committee members reviewed a draft survey that would soon be distributed to District families. The survey aims to gather insights into the community's priorities for the next superintendent. Committee members were asked to provide feedback on the survey. Each member had an opportunity to make recommendations on what the community survey should cover and how it should be disseminated. Dr. Shull advised that the responses to the survey would be used to craft the candidate application.

V. Review and Make Recommendations Concerning the Superintendent Search Process Timeline

Dr. Shull presented the superintendent search timeline, acknowledging its ambitious and aggressive nature. An external search firm will conduct candidate recruitment from February to March. Subsequently, a six-member Superintendent Screening Committee will review applications and submit recommendations to the Board of Education. The Board will select finalists in April, followed by interviews in May. The goal is to appoint and welcome the new superintendent by July 1, 2025.

VI. Establish the Schedule for Future SSAC Meetings

Dr. Shull proposed that the committee meet on the second Tuesday of each month for the next seven months.

VII. Adjournment
