Discussion:

Grant Chenoweth, Board Attorney, discussed the following: Per KRS 160.352. The various constituent groups have selected, elected, or appointed the required members to serve on the committee. The members present at the meeting were: Board Member: Greg Spencer, Principal Kelli Abney, Parent Representative Lauren Blake Smallwood, Teachers: Jennifer Brown and Wendy Crain-Lawson, Classified Employee Kelly Bowman. The board discussed the timeline for the superintendent selection process. It was determined that applications will be presented to the board at the April 17th Board Meeting. The Screening Committee will review the applications and submit their top three (but no more than five) candidates for consideration and the selection committee will conduct reference checks on the chosen candidates. Per KRS 160.352 (4), prior to appointing a superintendent of schools, the board of education shall consider the recommendations of the screening committee, but the board shall not be required to appoint a superintendent from the committee's recommendations.
