**1. CALL MEETING TO ORDER**

Chairperson Clem called the meeting to order at 2:08 pm.

**2. APPROVE AGENDA**

*Selecting a new superintendent is one of the most important, and difficult decisions that the Board of Education makes for the District. We not only consider the current needs of the District, but also the long-term future of our District in finding a candidate with the right experience and abilities to best meet those needs. It is a lengthy and tedious evaluation process for both the candidates and the Board, but we are committed to taking the steps necessary to hire the right candidate.*
