5. 2018-2019 Tax Rates (Propose To Leave Rates Unchanged)

Rationale:

KRS 160.470 requires local school boards of education to set tax rates within forty-five (45) days of receipt of certified property assessments. Our current tax rate is 52.2 for real estate and 52.2 for personal property (tangible). I am proposing that we leave tax rates unchanged: 52.2 for real estate, 52.2 for personal property, 52.2 motor vehicle/watercraft and 3% utility tax rate. The proposed rate was advertised for two consecutive weeks in The Times Journal, with a hearing held prior to this special called school board meeting. A copy of the "notice of hearing" is attached for your review.

<p style="text-align: center;">NOTICE OF HEARING</p> <p>The Russell County Board of Education will hold a public hearing at the Russell County Board of Education August 30, 2018 at 5:30 p.m. CDT to hear public comments regarding a proposed General Fund tax levy of 52.2 cents on real property and 52.2 cents on personal property.</p> <p>This leaves the rates unchanged from fiscal year 2018.</p> <p>The General Fund tax levied in fiscal year 2018 was 52.2 cents on real property and 52.2 cents on personal property and produced revenue of \$5,175,546.43. The proposed General Fund tax rate of 52.2 cents on real property and 52.2 cents on personal property is expected to produce \$5,335,716.56. Of this amount \$840,114.88 is from new and personal property. The compensating tax rate for 2019 is 51.7 cents on real property and 51.7 cents on personal property and is expected to produce \$5,284,608.17.</p> <p>The general areas to which revenue of \$160,170.56 above 2018 revenue is to be allocated are as follows: Cost of collections, \$6,406.82; instruction, \$153,763.74.</p> <p>The General Assembly has required publication of this advertisement and information contained herein.</p>
