7. Russell County School Nutrition-Amendment to Procurement Procedure

Rationale:

The Federal Office of Management and Budget (OMB), in accordance with recent statutory changes set forth in the National Defense Authorization Acts (NDAA), M-18-18: Memorandum for Chief Financial Officers and Heads of Small Executive Agencies, recently released a memorandum raising the threshold for micropurchases under Federal financial assistance awards from \$3,500 to \$10,000. This Memorandum also increases the simplified acquisition threshold from \$150,000 to \$250,000.
