On Monday, November 19, 2018, we received communication from Melson Roofing that they had miscalculated their roofing bid. Melson Roofing noted that their base bid should be: \$495,458.00 and the Alt. #1 \$81,776.00. This is an increase of \$160,800 for the base bid and \$35,095 for the alternate. I have attached the letter from Melson Roofing. The board has the right to reject any and all bids.
