8. 2019-2020 Tax Rates (Propose To Leave Rates Unchanged)

Rationale:

KRS 160.470 requires local school boards of education to set tax rates within forty-five (45) days of receipt of certified property assessments (we received the attached rate report on August 7, 2019). Our current tax rate is 52.2 for real estate and 52.2 for personal property (tangible). I am proposing that we leave the tax rate unchanged with tax rates of 52.2 for real estate and 52.2 for personal property. The proposed rate must be advertised for two consecutive weeks, hearing is to be held 7-10 days after the 2nd advertisement and is then usually adopted immediately following the hearing and prior to the 45 day deadline.

The current motor vehicle tax: 52.2

The current utility tax: 3%

NOTE: With rates remaining the same, it is expected that an additional \$53,462 will be generated.
