8. Application for Adjunct Instructor Certificate/Rate of Pay

Rationale:

Introduction: KRS 161.046 and KRS 161.048 calls for each board of education to approve part-time positions and the positions be filled by the best qualified candidate(s) available, as determined by the factors of academic preparation, prior teaching experience or related educational work, exceptional work experience, and personal attributes compatible with the demands of the teaching profession, and the specialty area for which certification is sought. The employment of this person in this part-time position will not result in the displacement of a qualified teacher with a regular certificate who is already employed in the district for the 2020-2021 school year. Applicants must sustain good moral character and is at least 18 years of age. All applicable background checks must be conducted on all applicants.

The application for adjunct instructor is needed for our EMT class that is going to continue at Russell County High School. Local paramedics will teach the class at the rate of \$20.00 per hour, for 5 hours of instruction per week and 2 hours of planning per week for a total of 7 hours per week. Additional instructors are occasionally present depending upon the skill being taught.
