15. January 2021-Return to In-Person Instruction

Rationale:

The COVID-19 Mode of Instruction Metrics for K-12 Education has been revised by the Kentucky Department of Public Health and Kentucky Department of Education (attached for your review). Under the new guidance, in-person classes can resume, even when a school district is "in the red" pending that the provisions in the metric and "Guidance on Safety Expectations and Best Practices for Kentucky Schools (K-12) are followed. I recommend that Russell County Schools resume the option of in-person classes on January 19, 2021, with a hybrid schedule for all grade levels.

In-person class option for students with last name A-L on Monday and Tuesday, In-person classes for students with last name M-Z on Thursday and Friday w/ all students virtual on Wednesdays for the schools to have extra cleaning/sanitation/disinfection. (NOTE: The oldest student in the household will determine the day the student attends if there are different children in the household with different last names that would put the students attending different days.)

A decision to cease in-person classes will be made based upon employee/student case rates and/or other factors related to COVID-19.

Resuming in-person school on January 19th provides additional time after Christmas/New Year's Eve gatherings to further reduce the transmission of COVID-19.

Parents/Guardians will have the option of children staying virtual for the entire 2020-2021 school year. Athletic and Extra Curricular Events need to be approved/denied on a case by case basis.

Order #8836 - Motion Passed: I recommend that Russell County Schools operate on a hybrid schedule as noted, once in-person classes resume (January 19, 2021) under the guidelines of the "COVID-19 Mode of Instruction Metrics for K-12 Education" issued by the Kentucky Department of Public Health and Kentucky Department of Education regarding classes and authorize the Superintendent to approve or deny participation in athletic events/extra curricular activities on a case by case basis- passed with a motion by Mr. Richard Kazsuk and a second by Ms. Sheila Wicker.

During a subsequent meeting of the local board of education, the local board shall adopt a school calendar for the upcoming school year that establishes the opening and closing dates of the school term, beginning and ending dates of each school month, student attendance days, and days on which schools shall be dismissed. The local board may schedule days for breaks in the school calendar that shall not be counted as a part of the minimum school term."

The draft 2021-2022 School Year Calendar/Schedule is attached for your review along with a copy of the input from students, parents/guardians, community members and employees of Russell County Schools regarding the draft.
