# 6. 2021-2022 Tax Rates (Propose to Leave Rates Unchanged)

#### Rationale:

KRS 160.470 requires local school boards of education to set tax rates within forty-five (45) days of receipt of certified property assessments. Our current tax rate is 52.2 for real estate and 52.2 for personal property (tangible). I am proposing that we leave tax rates unchanged: 52.2 for real estate, 52.2 for personal property, 52.2 motor vehicle/watercraft and 3% utility tax rate. The

proposed rate was advertised for two consecutive weeks in The Times Journal, with a hearing held prior to this special called school board meeting. A copy of the "notice of hearing" is attached for your review.

### NOTICE OF HEARING

The Russell County Board of Education will hold a public hearing at the Russell County Schools Auditorium/Natatoruim September 2, 2021 at 4:30 p.m. CDT to hear public comments regarding a proposed General Fund tax levy of 52.2 cents on real property and 52.2 cents on personal property.

This leaves the rates unchanged from fiscal year 2018, 2019, 2020 and 2021.

The General Fund tax levied in fiscal year 2021 was 52.2 cents on real property and 52.2 cents on personal property and produced revenue of \$5,528,953.64. The proposed General Fund tax rate of 52.2 cents on real property and 52.2 cents on personal property is expected to produce \$5,844,148.86. Of this amount \$816,865.83 is from new and personal property. The compensating tax rate for 2021 is 50.2 cents on real property and 52.2 cents on personal property and is expected to produce \$5,650.967.67.

The general areas to which revenue of \$315,195,22 above 2021 revenue is to be allocated are as follows: Cost of collections. \$12,607.81: instruction. \$302,587.41.
