## 11. Kentucky Department of Education COVID-19 Vaccine Incentive Payment Program

#### Rationale:

The Kentucky Department of Education (KDE) will use up to \$8.8 million in Elementary and Secondary School Emergency Relief funds to provide reimbursements to districts that have rewarded and acknowledged the time, energy and effort staff members took to get vaccinated.

All full and part-time employees of public school districts are eligible for a one-time vaccination incentive payment of \$100 after being fully vaccinated against COVID-19 (this also applies to school board members). This reimbursement is for employees who previously have been vaccinated, as well as those who have received their full vaccinations by Dec. 1, 2021. There will be enough funding to reimburse districts for approximately 88,000 local school district staff. Districts must pay employees first in order to receive reimbursement from KDE. Districts are strongly encouraged to consider providing additional funds that match the amount provided as reimbursement by KDE, but a financial match is not required for participation.
