The SBDM Allocations for certified and classified staff per Board Approved Staffing Formulas are attached to the Board agenda. Any increases or reductions in teaching staff are a direct result of the staffing formula which is directly tied to the projected enrollment numbers in that particular school for the 2022-2022 school year. The allocations for supplies, materials, travel, equipment, etc., (known as section 6 - this allocation can range from \$100 / ADA to 3.5% of the SEEK Base, \$140.00 for previous year). Due to carryover of SBDM and ESSER funding for the FY 22 school year, Section 6 funding has been reduced to the minimum of \$100 / ADA. Additions/reductions to each schools general staffing are summarized: TCPS- No additions no reductions TCIS No additions no reductions TCMS No Additions no reductions TCHS No additional instructional assistant added to Primary School due to need otherwise no additions and no reductions

in special education staffing for the FY 23 school year.
