F. Learning Loss Pay Rate

Revision of FY23 salary schedule for a standardized rate of pay for attendance visits. This rate is \$50 per hour for certified individuals.

G. Approve Emergency Certification

KRS 161.100 allows the Educational Professional Standards Board to issue Emergency Certification to an applicant when a district cannot secure a qualified applicant for a certified teaching position. A high school Allied Health Teacher vacancy was posted, there are no certified applicants. A Kentucky Educator Placement Service (KEPS) search was conducted and no qualified applicants could be located with this service. Additionally we have reached out to universities with teacher preparation programs and they could not provide any names of recent graduates who are certified. We have a candidate who holds a B.S. in Nursing and would be committed to earning their teaching certificate; I am recommending that you approve this applicant for Emergency Certification in Allied Health for the vacancy at the high school.

H. Equipment Grant

I am in the process of writing an equipment grant for \$25,000. The piece of equipment I am writing it for is our dishwasher. I wrote the grant for one last year but was not successful in the grant award. Our dishwasher is 23 years old and is difficult to get repair parts for because of its age. A newer dishwasher will be more energy efficient and cost effective. Last year, the quoted price was \$68,000, I feel certain this price has increased to probably somewhere close to \$75,000. Nonetheless, \$25,000 would cover at least 1/3 of the cost.
