II. Notice of Hearing

The Trigg County Board of Education will hold a public hearing at the Trigg County Board of Education located at 202 Main Street, Cadiz, KY 42211, on Friday, December 9 at 12 p.m. to hear public comments regarding a proposed tax levy of 58.9 cents on real property and 58.9 cents on personal property. The General Fund tax levied in fiscal year 2022 was 54.8 cents on real property and 54.8 cents on personal property and produced revenue of \$5,387,967.40. The proposed General Fund tax rate of 58.9 cents on real property and 58.9 cents on personal property is expected to produce \$6,427,995.10. Of this amount, \$672,542.49 is from new and personal property. The compensating tax for 2023 is 52.8 cents on real property and 52.8 cents on personal property and is expected to produce \$5,762,277.45. The general areas to which revenue of \$1,040,028.10 above 2022 revenue is to be allocated are as follows: Cost of collections, \$41,600; building fund, \$621,968; instruction, \$350,000; transportation, \$10,000; and maintenance of plant, \$16,460.10.
