For the 2018 community service event, there are 370 volunteers registered to work on 44 senior citizens' homes in our district. Mark Krummen and Kevin Ryan will be delivering 500 bags of mulch to homes next week in preparation for the project. Mrs. Schutzman reported that they have the manpower to work on a few more homes, so it is not too late to contact neighbors in the community to request help with their landscaping.
