II.A. Spotlight Report - MS and HS Music Programs

Mrs. Amber Hedges, middle school music teacher, explained the process of selection for Northern Kentucky Select Band and introduced the five students from WVMS – RJ Bowen, French horn; Logan Pronk and Ben Turner, trumpet; Graeme Danzer, trombone; and Hannah Stanley, clarinet - who were part of this ensemble. Hannah, an 8th grader, played an excerpt from the clarinet audition piece.

Mrs. Erin Core-Stine, high school music and drama teacher, spoke about some of the choir highlights thus far for the year, including a full choir performance at a Cincinnati Cyclones game, solo and ensemble assessment, and 7 high school students being selected for KMEA All State Choir. Jonah Duncan and Bladen Utterback told the Board why music was important to them, then an ensemble sang a verse of John Dowland's *Come Again*.

Both directors thanked the administration and the Board of Education for their support of the music programs at Walton-Verona.
