II. Informational Items

II.A. Gifted & Talented Program Update – attachment 1

Michelle Gregg discussed the Gifted and Talented Program. Aaron Linville is the district Gifted and Talented Teacher. The program has increased this year by 38 students with a total of 273 students in the district participating. The delivery of the program varies by school. Ms. Stacey Thornberry asked about the program specifically at the high school. Ms. Gregg discussed the format at the high school in that Mr. Linville works with each student based on their identifying criteria and then works with the student to determine the best placement for programs and projects. Ms. Stacey Thornberry asked if a student could opt out of this program. Ms. Gregg stated that a student could opt out of the program. Mr. David Turner asked about how the program has been impacted with NTI days. He also asked if any of the gifted and talented programs that we cancelled would be rescheduled (i.e. DreamFest). Ms. Gregg stated that she was not sure about anything being rescheduled, but did not feel like that was likely. As far as continued gifted and talented instruction during NTI, Mr. Linville is continuing to collaborate with teachers, reaching out to students and sitting in on Zoom classroom meetings when needed. Mr. David Turner asked about plans for the program moving into next year in the event given the

situation with social distancing. Ms. Gregg feels like things could look different next school year depending on the situation. Rather than completing projects electronically, perhaps they would present them interactively with their peers.

II.B. Principals Report - attachment 2-4

Dr. Baker discussed the Principals Reports with the board members. At the elementary school, he discussed the overwhelming and tremendous support for a staff member. He discussed the math curriculum exploratory committee. In addition, current kindergarten registration number are at 94 students in-district as well as 17 out of district students. At the middle school, he discussed planning for next year. The master schedule will be adjusted in effort to meet the needs of struggling learners specifically in reading and math, as well as support students in RTI. At the high school, he discussed ACT scores and our rank as 9th in the state. He also updated the current plan for senior activities. Ms. Megan Jones asked if Mrs. Nesmith would attend at the July activities for seniors. Dr. Baker advised she would attend. Ms. Megan Jones asked about a reverse parade at the high school. Dr. Baker discussed his concerns with this. Mr. David Turner asked about RTI, specifically at the elementary school. Dr. Baker stated that he would be meeting with administrators to determine how to fill gaps that have been created by NTI days. Mrs. Heather Stewart asked about Google classroom and if there was any feedback from students or teachers for that platform. Dr. Baker stated nothing specific, but he would work to determine what the best platform has been for both students and teachers as we move ahead.

Dr. Baker discussed the attendance/enrollment report. We have grown by 53 students over the course of the school year.

II.F. Discussion of Quest field trips - attachment 7

Dr. Baker discussed the proposed quest field trip for the high school. He is recommending that the trip be postponed until next summer. The originally selected students will be able to go next year as well as 4 additional students to be selected for a total of 20 students. This would require one additional sponsor for next year only. Ms. Heather Stewart asked if this had been communicated to students. Dr. Baker stated he did not believe since we are just starting discussion. Ms. Heather Stewart stated she wanted to get an estimate of liability coverage for the students next year. Mr. David Turner stated he felt like this was a good compromise and asked if the selection criteria would change. He felt like this was a missed opportunity for 12 students next year and wanted to see if we could expand beyond the 4 additional students, potentially to 8 students. Dr. Baker will discuss the selection criteria and agrees with expanding this to additional students next year. Mrs. Megan Jones asked if expanding would require another sponsor. Dr. Baker stated that it would.

II.G. Other

Dr. Baker discussed meeting with administrators in the morning. He discussed working on plans for next year. He would like to avoid starting the year on NTI days. Dr. Baker also discussed the track issues since 2018 and the options that were suggested to fix the track. Based on failures in the test strip, the recommendation is to build a new track. The plan is to bond this project so that is does not have to be paid for all at once. Ehmet Hayes discussed different track coatings and products. Mr. Kyle Art asked about warranties and life span of the track based on the different products presented. Mr. Hayes said he would look into this. Mr. Kyle Art asked if there were similar tracks in the area that could be visited. Mr. Hayes will work to coordinate this. Mr. David Turner states that the test strip failure was a success in that we have answers at this point. He feels like we have a water issue at the root of the issue and that a complete redo of the track in the manner presented is needed. He appreciates the creative funding options to make this more palatable. Mr. Kyle Art asked about the original project for the entire complex, including the track. Mr. Hayes stated he was the original architect on this and detailed the drainage that is currently in place. Ms. Heather Stewart asked about stopping the food service emails. Dr. Baker will address that issue. Mr. Kyle Art again restated that it is great to be a part of the family atmosphere here at Walton-Verona. Ms. Stacey Thornberry asked about the assistant principal position. Dr. Baker stated he is hoping to have an announcement on this by mid-next week.

Dr. Baker stated that we will be removing the audience of citizens based on an executive order from Governor Beshear until we are able to meet again publicly. Board Attorney, Claire Parsons spoke about this as well.



Walton-Verona Elementanglition of Excellence School Council Report for Board of Education 4-23-20

- March proved to be a very challenging month for WVES through the loss of a spouse of one of our teachers, followed by the movement into NTI due to the COVID-19 pandemic. I don't bring this up to dwell on the difficult, but to celebrate the positives. Our staff, with the support of the folks at the central office, the middle school, and the high school, was able to work through this adversity in a way that's frankly just remarkable. On March 6th, were able to have 13 folks be there for their colleague in her moment of need for the entirety of the school day as well as have 3 others that were out of the building for part of the day (including me). Amazingly, we had no "holes" in coverage, and for the most part, the school carried on business as usual. The staff present in the building were able to keep WVES the school filled with smiles even though on the inside we were mourning for one of our own. As awful as that tragedy was, it will be remembered as a time that the school community pulled together, to show what we're made of, and why Walton-Verona Elementary is special beyond academics.
- Immediately following this week, we entered into the uncertainty of NTI. We had about 2 days to prepare NTI, and our teachers responded under pressure, preparing at minimum 2 weeks' worth of NTI in approximately 48 hours. The following week, I took a survey of the teachers to see how NTI was going, and on a scale of 1-5, 56% indicated it was going well (4 or 5), 44% indicated it was going alright (3), and 0% stated it was going poorly (1 or 2). The thing that impressed me even more so than the quick turnaround was the compassion and understanding our teachers were able to display. They understood not only would NTI look different than their typical classes, but they also understood there would be a great degree of variation of supports at home for students. They created NTI classwork that was approachable for families and not overwhelming while also providing the opportunity to go further if the family wanted to. The feedback we received from parents was very positive.
- The Math Curriculum Exploratory Committee met on March 10th to close out our meetings for the year. We discussed the essentials of what a useful math unit and assessment has and began the conversations of what this will look like in combination with UBD moving into next year. We are planning on dedicating a significant amount of time in our PD plan for this work, with attention being given to creating a better holistic math program for WVISD. We also discussed an exciting resource that Ms. Stephens brought to our attention that we will be reviewing over the summer. The link to the resource is http://www.sfusdmath.org/accessing-core-curriculum-unit-plans.html and is available for free through Creative Commons.
- On April 3rd, we held a Reverse Parade through the ES parking lot. The turnout was huge with cars lining up down Porter Road. We were able to have a brief connecting point with our community while keeping our students and staff safe. The "live video" on our district Facebook page has had approximately 3,000 views! Considering all that's going on, it was a positive community event while staying within the social distancing parameters set forth by our government.

WVMS 2020-2021

Planning for the 2020-2021 School Year had already been in progress well before NTI Days were put into place. Several very important pieces have been finalized over the past month:

- Adjusted master schedule to better meet the needs of our most struggling learners.
- Developed Supplemental Resource for special education to meet daily.
- Co-Teaching schedule set up to strengthen co-teaching in reading and math classrooms.
- RTI Time during school day will be improved so that groups meet daily.
- Recess time scheduled separate from RTI Time and limited to 2 days/week for 30 minutes.
- Moved Social Emotional Learning (SEL) Programming to Mondays instead of Fridays to better support all students' needs.
- Budget SBDM Funds to continue to purchase classroom mini-labs. Focus will be on reading and math classrooms first.
- Continue Workshop Model Classroom, Kagan, Thinking Strategies in all classes

NTI Participation and Attendance

WVMS has been tracking student participation during NTI days using two tools. One is a spreadsheet that teachers track students work rate each week then attendance is calculated from that sheet. The second tool is a school-wide classwork matrix that Mr. Luken developed for us to use. Each teacher lists the work for their class each day throughout the NTI process which allows administrators and central office staff to view what students are working on for each class, each day. This will also be used as our evidence for KDE regarding our NTI Instructional Days.



Some warranty items are still being completed. Control system issue, Lawn reseeding in front of middle school, and leaking windows.

Change order 6 is on the agenda for approval. As stated this was covered already in the revised BG1. This change order will not change the project cost at all.

Proposal 34 was to help with the distance the windows were opening next to the sidewalk for safety as you are walking. At the rooftop locations, stops were added to keep you from climbing out onto the roof through the windows inside the classrooms.

Proposal 35 was for extra money relating to the kiln that Delta Electric fried when they hooked it up with the wrong voltage. Money was paid through Hayes for STW engineers and MS Art dept. paid for extra cost due to upsizing the kiln for increased capacity. This gave us a larger and better kiln. Worked out nicely.
