II. Informational Items II.A. 2020 Graduation Plan

Discussion:

Dr. Baker discussed the graduation plan, which is scheduled to take place at Florence Baptist Church on July 31st. The graduates will be split into two groups in effort to support social distancing, however all graduates will be permitted to attend both ceremonies. Dr. Baker did stipulate that the plan may need to change based on changes with the COVID-19 situation.

III. Recommended Board Motions III.A. Approval of the 2020-2021 School Re-Entry Plan

Discussion:

Dr. Baker stated that he feels that the recommended plan is in accordance with other districts in our area. He did stipulate that while we would like to get a plan in place, this is subject to change based on any changes regarding COVID-19. Dr. Baker discussed the survey results and stated his recommendation of moving forward with the Hybrid Plan with the option for all parents to choose Virtual Instruction if that is their preference. Ms. Stacey Thornberry asked how things would work if a student or staff member tests positive for COVID-19. Dr. Baker stated that we would collaborate with the Health Department in this situation. He plans to release additional information regarding this and other similar situations soon. Ms. Stacey Thornberry asked about students working at the elementary school and how teachers often work hands on when teaching subjects such as writing. Dr. Baker stated that we may have to rethink how these things are done and in some case add additional PPE in effort to support this. Ms. Stacey Thornberry asked how attendance would work if students go back and forth between the Hybrid Plan and Virtual Model. Dr. Baker stated that we are working on plans for this. We will be asking parents to commit to one or the other within a specific period, while still trying to be as flexible as possible. Ms. Stacey Thornberry asked about social distancing on the school bus. Mr. Chris Schadler discussed standards set by KDE. Ms. Stacey Thornberry asked about what the Virtual Model will look like. Dr. Baker stated that he would like to get more information from our teachers and principals to make determinations on what form this will take. Dr. Baker stated that this could be different from teacher to teacher. Dr. Baker discussed student regression during summer break, specifically coming from NTI directly into summer. Ms. Michelle Gregg discussed how our district plans to combat this during the upcoming school year. Ms. Megan Jones asked about the Ignite Academy. Dr. Baker stated that he has spoken with Mr. Hogan regarding this and Boone County Schools has not made any determinations at this time. Ms. Megan Jones stated that while she does feel like the options for parents are good, but there should not be a lot of movement between plans so as not to burden the teachers and staff. Again, Dr. Baker stated that depending on the COVID-19 situation in our state and our area over the next few weeks, any plans that are made are subject to change.
