#### II. Informational Items

#### II.A. Discussion of Tax Rate (no changes)

Kevin Ryan discussed the notice of hearing regarding tax rates and the tax hearing that will take place on 8/27 at 6:30 PM. There are no changes to the tax rate. Mr. Ryan discussed the tax rate revenue information sheet. He additionally stated that he expects to hold a tax hearing each year from this point forward.

#### II.B. 2019-2020 IMPACT survey data

Dr. Baker discussed the IMPACT survey that is completed by certified employees across the state. While there were several good indicators for our district, there were some opportunities as well. There were areas for improvement across the board, but the middle school had the lowest ratings. Dr. Baker discussed how he plans to help our schools improve, including another survey in the spring, leadership training and a book study that focuses on customer service.

#### **II.C. Discussion of Superintendent Goals**

Dr. Baker discussed his superintendent goals. Dr. Baker would like to get at least one specific goal from each board member for more direction moving forward. The board members discussed this and determined that they would like to continue with standard four - Human Resources. Dr. Baker stated that he would like to get to the root of what each board member is passionate about so that he can be sure to focus on those issues. Dr. Baker asked to meet with each board member individually to work toward this.

#### II.D. Other

Dr. Baker apologized for our technical difficulties last week. Dr. Baker discussed Governor Beshear's recommendation on August 10th to push in-school instruction to September 28th. While this was a recommendation, the next day there was communication from KDE that demonstrated that this was more than just a recommendation. Dr. Baker discussed the difficulty in making the decision to postpone in-person instruction. Dr. Baker discussed the new guidance from KDE that was released today that would allow our students to enter our buildings, up to 15% of the total enrollment, for targeted services. These services could include mental and emotional appointments with our counselors, OT/PT/Speech Therapy, as well as other services.
