Dr. Baker also discussed virtual instruction vs. in-person instruction. Ms. Stacey Thornberry asked about the percentages for in-person and virtual students. Dr. Baker will provide that information to the board. Ms. Megan Jones asked about consistency in delivery of instruction across the hybrid plan. Mr. Adam Nash discussed that this may vary by teacher based on the content involved. Mr. David

Dr. Baker stated that one change that has come up that can enhance virtual instruction is the ability to bring students in for targeted services.
