The Instructional team continues to work hard with Curriculum questions and continues to write grants, Shriving Readers, Novice Reduction and school Improvement Fund. The District Improvement plans are posted on the website. Continue to make progress on action plans. KSBA continues to provide training. Some board members attended the fall regional meeting which was held in Lee County earlier this month. Superintendent Watts talked about the cleanliness of the schools. Mr. Watts also addressed how much the schools facilities are being used and referenced, basketball both boys and girl's high school and elementary, cheerleaders from all schools, volleyball, football, band and there was more after school activities. The District Facility plan was approved by the Board of Education and KDE.

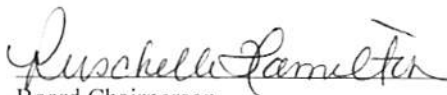
