**I. Call to Order/Roll Call**

Superintendent Phillip Watts stated the coliseum fire started around the ring and there was a contractor (Bri-Den Roofing) on site working at the time. The firefighters was on the scene, hooked up the water, and was able to put out the fire. Facilities Director, Will Noble and myself has been very busy going through interviews and working with the insurance companies and vendors to put the coliseum back as nice as we can. Mr. Watts stated, "We want this put back right for our students". The restoration company has been on the ground working on the water and smoke smell. Mr. Watts stated we are asking for support from the board. Mr. John Hollan, board member, wanted to know the damage, in regards to smoke in the school. Mr. Watts stated, it started up through he gutters and I don't' have the official fire report this is just my opinion. The fire started around the ring around the stage area and then around the windows. It is a quarter of the gym. It did go up a few feet on the walls, most of the damage is from the water, and they had to punch holes in the roof. There is fire damage and a lot of smoke. Mr. Watts stated there is no dollar amount and it is too early at this time to know the exact extent of damage. Mr. Watts stated we have to meet with architects and structural engineers to determine the extent of the damage. MR. Watts stated we should have some update Friday of next week.




**IX. Adjournment**
