**PRESENTATIONS**

BCPS Virtual Learning Plan

Specialized Programs Principal Danny Clemens gave a PowerPoint presentation of the BCPS Virtual Learning Plan. Questions were asked by all board members and addressed by Mr. Clemens and members of the district Student Learning Department. No official vote was taken but a consensus by the Board was in favor of the plan.

## **GENERAL DISCUSSION**

### Remote Learning / Return to 5-Day Instruction

Superintendent Jesse Bacon introduced the topic of remote learning Wednesdays. After much discussion, Dr. Bacon recommended only elementary students return to five days a week after spring break and the four day a week schedule for middle and high school students be left as is.

- 2021-050- Motion made by Darrell Coleman, seconded by Linda Belcher, to approve Dr. Bacon's recommendation for only elementary students return to a five-day in-person instructional week beginning the week after Spring Break. All members voted YES.

### Current Legislation

Dr. Bacon mentioned pending legislation and expressed opposition to House Bill 128.

### BEHS Basketball – State Tournament

Dr. Bacon announced that any student that attends the state tournament for either the boys or girls basketball team can bring back a ticket stub and be allowed an excused absence.
