Board Chairperson Debby Atherton called the October 18, 2021, regular meeting of the Bullitt County Board of Education to order at 5:00 p.m.

**GENERAL DISCUSSION**

Review of Academic Progress and Initiatives

District Assessment and Research Director Jan Stone presented the State Assessment District Data Report. Assistant Superintendent Adrienne Usher relayed plans from the district level on addressing areas for improvement. Elementary Education Director Patrick Durham spoke about results and plans for the elementary level. Secondary Education Director Rachelle Bramlage-Schomburg shared plans for the middle and high school levels. Troy Kolb, Director of Special Education, talked about areas of focus and strategies for students in all levels receiving special education instruction.
