**1. C&H Audio Visual Services - Graduation 2022**

**2. Bang The Table Contract**

Due to a very significant pricing increase for ThoughtExchange, the district seeks approval to enter into a contract with Bang the Table for \$22,500 as the new community/staff engagement platform beginning July 1, 2022 and running through June 30, 2023.
