Haven Care Center representatives presented a program they would like to implement at the middle school.

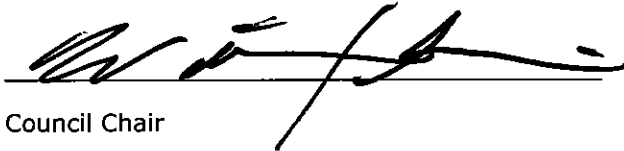

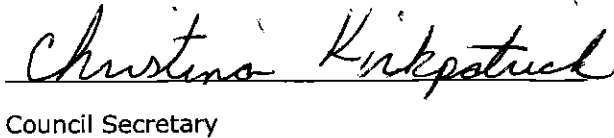
