1. Children's Home of Northern Kentucky Update

Mr. Rick Wurth, CEO of the Children's Home of Northern Kentucky, thanked the Board for their continuous partnership. With the expanding need in behavioral health, the Children's Home of Northern Kentucky is becoming a Behavior Health Program that offers a variety of treatment services. They are continually growing their Outpatient Services, including school-based services. In March of 2018 they launched the Day Treatment/Partial Hospitalization Services and Psychiatric Residential Treatment Facility and now focusing on expanding their outpatient services for adults with a goal of establishing additional outpatient service locations.

2. Transformational Learning Center Annual Update

Ms. Lorie Duffy, Transformational Learning Center's Principal, updated the Board with their annual update. Teachers collaborate in their Professional Learning Communities (PLC). They focus on student behavior data, KPREP data and ways to increase student achievement. TLC continues to collaborate with Holmes High School, Holmes Middle School, Elementary Schools, Day Treatment, Adult High School, Workforce, and Youth Build. The professional development at TLC focuses on behavior and trauma informed care. TLC implements Foundations and PBIS as their behavior supports. The staff at TLC maintain relationships with staff members at both the high school and middle school to adjust to the curriculum that is being taught to keep the students who transition back and forth on track.

3. Membership Attendance ~ Fourth Month

The Membership Attendance for the fourth month was presented by Mr. Ken Kippenbrock, Director of Pupil Personnel. Glenn O. Swing Elementary led the district with the highest attendance percentage at 96.50% for month four.
