6. Brigance Kindergarten Assessment

Ms. Suzanne Thompson, Elementary Director and Mr. Bill Grein, District Assessment Coordinator, presented the Brigance Kindergarten Assessment Data. The data shows that students who attended Biggs (State Funded Preschool) decreased from 52.6% ready for kindergarten in 2017-18 to 39.3% ready for kindergarten in 2018-19. Covington students who did not attend preschool during the 2017-18 school year decreased their kindergarten readiness from 30.6% to 22.3% ready. Overall kindergarten readiness for Covington's kindergarten students decreased from 48.1% ready in 2017-18 to 36.2% ready in 2018-19. The data also compares the students in eight of our neighboring districts along with the state. The data compares how the state-funded preschool students did locally and how the other local districts did with their overall kindergarten population.
