Highlights from their last Focus Visit were improvements in every area in learner engagement such as; active participation, learning environment, formative processes and tools. Rigor scored higher on thoughtful work, highlevel questioning and academic discussion. Holmes High School implemented Teacher Mentoring Meetings each month for new teachers and other fun activities to improve climate and culture. Professional development continues with ongoing technology support. The student support team has been working diligently to ensure compliance with the Department of Justice and providing proactive support for the most at-risk students. HHS is continuing to focus on PBIS and CHAMPS, reducing the numbers of skipping and tardies to class. HHS holds monthly ITeam meetings to assign essential standards, supporting standards, and vertically align with the middle school.
