VI. Informational Items (Action Possible)

1. Transformational Learning Center Annual Update

Ms. Lorie Duffy, Principal provided the Board with the Transformational Learning Center annual update. The alternative school, TLC, has won the Alternative Program of Distinction for five years. Collaboration has changed due to COVID, they meet virtually instead of inperson. During collaboration, they focus on student progress data and interventions to put in place.

The staff attended many professional development opportunities over the summer. Feedback from the staff is they felt more prepared at the beginning of this school year. They were able to learn and fix issues they had back in March of 2020.

The staff at TLC have been included in the district curriculum development process. This has led to more relationships and better communication with staff members at the high school, middle school and elementary schools. TLC is now 1:1 with technology. Technology is used to enhance learning with programs such as; Lexia, Edgenuity, writing assignments and daily reflections.

2. Remote Learning Update

Mr. Scott Alter, Assistant Superintendent updated the Board on remote learning participation rates. As of January 4, 2021, student participation, district-wide is 96%. Mr. Alter provided to the Board, KDE's guidelines that we must follow for student participation.

3. 303 Court Street ~ PILOT and LPA Agreement

Mr. Jim Parsons, Attorney, Mr. David Okun of Al. Neyer, LLC and Mr. Danny Lipson with Urban Sites, LLC discussed the project overview for 303 Court Street development. The \$31 million project will include 133 riverfront property residential units and 6,165 square feet ground floor commercial area that will be called 303CT @ Roebling Point. The proposed PILOT payment of 20% of the \$57,294 and additional tax revenue from commercial businesses on first floor is in the agreement for consideration.

4. Creation of a Temporary Part-Time Position for 2020-21

Mr. Scott Alter, Assistant Superintendent of Learning Support is requesting the creation of a temporary part-time position to assist district leadership in managing State and Federal Programs for the remainder of the 2020-21 school year. Over the summer the Elementary Director Position (Retirement) was posted and not filled. The position remained in the budget. Remaining Title 1 funds will support this part-time position at no cost to the General Fund. This position is for the remainder of this school year. The item will be brought back on the consent agenda for the next scheduled Board meeting on January 28, 2021.
