- a. Upon acceptance of this agreement by the Board, McKinney shall be issued a Kentucky teaching certificate upon providing written proof to the Board that s/he has completed the following conditions:
 - 1. Any training under the heading of "Educator Ethics" on the attached pre-approved Board training list (Attachment A).
 - 2. The specific training "Honesty at Work" on the attached pre-approved Board training list (Attachment A).

McKinney shall pay any expense incurred. McKinney shall not be issued a certificate until such conditions are satisfied.

- b. Any and all certificates issued to McKinney shall be subject to the following conditions for ten (10) years:
 - 1. McKinney shall not be convicted of nor enter a guilty or no contest plea to any criminal charge(s) other than "minor traffic violations." A violation is not considered a "minor traffic violation" if it is an offense for which jail time may be imposed. If McKinney is convicted of, or enters a guilty or no contest plea, to any criminal charge other than minor traffic violations, s/he shall submit this information to the Board, in writing, within thirty (30) days. If McKinney fails to satisfy this condition, any and all certificates issued to her shall be administratively suspended pending Board review and disposition.
 - 2. McKinney shall submit an official copy of her current criminal record, as prepared by the Administrative Office of the Courts, with any application for renewal of her certification(s) and/or for additional certification(s). McKinney shall pay any expense incurred. If McKinney fails to satisfy this condition, any application submitted on her behalf for certification renewal and/or an additional certificate shall be denied.
 - 3. McKinney shall not be permitted to assume any fiscal or financial management responsibilities as part of her employment, regardless of permission by any employing authority. McKinney shall submit written proof from her direct supervisor attesting that McKinney has not assumed any fiscal or financial management responsibilities during the last calendar year on May 1st of each year of her probation. If McKinney fails to satisfy this condition, any and all certificates issued to her shall be administratively suspended until the Board receives the written proof.

- 1. During the probationary period, Baskett shall not receive any disciplinary action from any school district in the Commonwealth of Kentucky. "Disciplinary action" is defined as any suspension, termination, or public reprimand issued by any school district in the Commonwealth of Kentucky and upheld, if requested, by either the tribunal and/or arbitration process. Failure to uphold this condition will result in Certificate 200703610 being administratively suspended pending further Board review and disposition.
- 2. Baskett shall not be permitted to supervise any students in any restroom and shall only use staff restrooms, regardless of permission by any employing authority. Decision

Accept the hearing officer's Findings of Fact, Conclusions of Law and Recommended Order that:

- a. Certificate Number 201219838 shall be suspended for a period of one hundred eighty (180) days from the date of the Final Order. During the suspension period, Maddox shall not be employed in a certified position in the Commonwealth of Kentucky.
- b. Maddox is reprimanded for his lack of professional judgment in interactions with students. As an education professional, it is Maddox's responsibility to set and maintain appropriate boundaries with all students. He must be ever vigilant to treat all students with fairness and equity, careful never to single out a particular student for special treatment and/or friendship. Furthermore, as a teacher, it is Maddox's responsibility to maintain a safe and positive learning environment at all times. He must make every effort to protect the health, welfare, and safety of those in his care.
- c. Maddox is not currently employed in a certified position, but holds a certificate currently set to expire on June 30, 2026. Maddox shall notify the Board in writing of his intent to return to certified employment, at least ten (10) days prior to returning to a certified position. If Respondent fails to satisfy this condition, Certificate Number 201219838 shall be administratively suspended, pending further Board review and disposition.
- d. Prior to the date one hundred eighty (180) days from the date of the Final Order, Maddox shall submit written proof to the Board that he has completed the following trainings:
 - 1) At least two (2) hours on Cultural Competency and Responsive Teaching.
 - 2) At least three (3) hours on Appropriate Student-Teacher Boundaries.
 - 3) At least three (3) hours on Preventing Sexual Harassment and Abuse of Students by education personnel, as approved by the Board.

In order for the trainings to fulfill this requirement, Maddox shall petition the Board for pre-approval of the training by following the process outlined on the Board's website. Any cost for said training shall be paid for by Maddox. Failure to submit written proof of completion on or before the deadline

will result in Certificate Number 201219838 being administratively suspended until such time as the Board receives the written proof of completion.

- e. Upon reinstatement, Certificate Number 201219838 shall be subject to the following conditions for a period of two (2) years:
 - 2) Maddox shall not receive any disciplinary action related to inappropriate interactions with students from any school district in the Commonwealth of Kentucky.

"Disciplinary action" is defined as any termination, suspension, or public reprimand issued by any school district in the Commonwealth of Kentucky and upheld, if requested, by either a tribunal and/or arbitration process including any appeal therefrom.

Failure to abide by this probationary condition will result in an administrative suspension pending Board review and disposition.

f. Maddox is warned that should he violate KRS 161.120, either during or following this probationary period, the Board shall initiate new disciplinary action and seek additional sanctions.
