A. Update

Superintendent Mr. Charlie Brock updated the board on his last standard, Human Resource Leadership. During this update, Mr. Brock mentioned getting out earlier job postings and how they helped get the top candidates. Our New Teacher Support team was selected to present at the Continuous School Improvement Summit next Fall.

We have a few things lined up for next year. We are looking into socialemotional support for our Teachers, including clinical counseling to help them with stress and emotional support. This will also help in retention and be an employee benefit. More about this in June. We will also be doing a Leadership program of our own next year. This will be for those individuals who want to become leaders in our district or grow their leadership skills.

Our District will have Professional Development on May 23rd and 24th. Thoughtful Classroom will be in the District. This program is centered around high-yield instructional strategies and engagement strategies for K-12.
