Finance Director/Treasurer, Kelley Gamble presented a slide presentation to the Board. The presentation consisted of statistics for the following:  
Expenditures FY 2015-FY 2020; GF Salary Costs FY 2015 - FY 2020, which showed an 8/10% average annual increase; GF Employee Benefit Costs FY 2015 - FY 2020; Staffing and Salary Data, showing Average Classroom Teacher Salary was ranked 139th of 172 districts; GF Non-Personnel Costs FY 2015 - FY 2020; GF Total Revenues FY 2015 - FY 2020 Cumulative Revenue decreases since 2015 = \$2,396.100; GF Tax Revenues FY 2015 - FY 2020; Utility Tax Revenue FY 2015 - FY 2020; GF SEEK Revenues FY 2015 - FY 2020; and the Actual Contingency Balances FY 2015 - FY 2020. One of the items of discussion was to use Title I money for purchase of Chromebooks and hold CARES money for Food Service costs.
