He thanked all the administrators for all their dedication and hard work. He advised that the State legislation will be adding a lot of "COVID" related bills this year. Chairman Davis reminded the Board that he has always been against school rankings.

However, until legislation changes, there is not much we can do. Chairman Davis thanked all the administration staff once more. Superintendent Hammond added, once we go forward we need to realize the relationships that these kids have at home, we need to show some compassion and work with them as much as possible. Because these issues have magnified, at this time. He also added that it won't be long until time to work on the budget is here. He advised that one of KDE's requirements was to cut 8% of their budget.
