#### Discussion:

Ms Beatty updated the Board, the CDC reported on July 9th, all children older than two (2) should wear masks.

After discussion it was decided to leave it up to the District level, as nothing is mandatory at this time. Ms. Beatty has talked to Health Dept, they are recommending using the tier system. If high, in the red, they would recommend changes. Hargis asked where they get the info to know if a child has been vaccinated?

Ms. Beatty replied that most nurses can get info from the state registry provided through Health Depts.

Attorney, Jake Thompson advised it is only voluntary to wear masks at this time.

Hargis Davis advised that he believes it is not any school's business to be able to log into system/registry.

Ms. Beatty reminded everyone that she is still responsible for mandatory quarantines, if it applies. If parent won't release info advising if child is vaccinated, she has no choice but to quarantine.

Triad Health Systems is coming to school for clinic on Tuesday, July 27th. The Health Dept will be at Redifest for vaccinations. They will set up appointments for children that need regular childhood vaccines.

Jake advised that KDE is not going to enforce masks on buses.
