Superintendent's Report

Chairwoman Diane Porter, members of the Board; it is my pleasure to call your attention to a few items of special interest.

Congratulations to Julia Bauscher, JCPS Director of School and Community Nutrition Services. Julia was installed as president of the School Nutrition Association at last month's annual national conference in Boston and is featured in the August 2014 issue of the School Nutrition Association publication. The School Nutrition Association is the national organization of school nutrition professionals committed to advancing the quality of school meal programs through education and advocacy. VI. Action Items

VI.A. Selection of JCPS School of Innovation Design

Dr. Robert Rodosky; chief of Data Management, Planning, and Program Evaluation; Dr. Dena Dossett, director of Planning, and Jonathan Lowe, director of Student Assignment, presented information and answered questions concerning the School of Innovation design proposals. Each Board member had an opportunity to comment and ask questions. Several Board members stated that Administration should come back in September with additional information including budget and location.

Mr. Jones: "I move that we name as winners of the School of Innovation contest The Catalpa School and the Louisville Reach Academy and that we authorize the next-phase of planning to go forward with the superintendent come back with budget, as has been requested, but also with specific waivers. My concern is that we're just going to ask existing schools to do this, and that's not innovation, that's just piling on top of busy people. So, I want to see the actual change that we're asking for. So, go forward, but come to us with specifics that we can then bless so they get funded and you go to Frankfort with

it. Metro Museum Magnet School is a fantastic idea—there's no question that it's innovative. The only reason not to include it is it requires deeper work with the community because we're not going to fund it out of this budget cycle. We need to work with community partners to find the building and the dough to stand it up if we want to do that. And the Next-General Community School, I think the ideas are already adopted really, and they're going to empower folks who are on that path in a better way. So, the motion is, name the two and let's roll; come back with whatever you need for the other two."

Mr. Haddaway requested that Mr. Jones restate his motion a little more concisely so Board members are clear on what they are voting on.

Mr. Jones: "I move that we name The Catalpa School and the Louisville Reach Academy as the winners of the School of Innovation contest and that we ask the superintendent to move forward with the planning and come back to the Board for approval of whatever budget is needed and authorization to submit a waiver request."

VI.B. Update on Magnet School Review

Dr. Robert Rodosky; chief of Data Management, Planning, and Program Evaluation; presented information concerning the recommendations contained in Magnet Schools of America's magnet school review and the proposal to discontinue the magnet status for Jacob Elementary School, McFerran Preparatory Academy, Rangeland Elementary School, and Rutherford Elementary School for the 2015–16 school year. Each Board member had an opportunity to comment and ask questions.

Mrs. Haddad asked for clarification concerning the attachment, *Status Update on MSA Recommendations*. Dr. Rodosky noted that the attachment was provided as information only and was not part of the recommendation. Chairwoman Porter noted that this had caused confusion and requested that, in the future, informational documents be provided in a different venue.

Mr. Jones stated that there needs to be a timeline and actual plan for any recommendations concerning the magnet schools. "We had a very powerful critique of the magnet program come in here, and we can't just sit here and let it linger out there."

But it warrants conversation, so please bring something back to the Board."

Dr. Hargens: "Absolutely. We'll bring a timeline—a very specific timeline to the Board."

VI.C. Report on Impact of Telecommunication Devices Policy Waivers and Approval of Waivers for the 2014–15 School Year

Karen Branham, assistant superintendent, Curriculum and Instruction; Sharis Lattimore, director of Computer Education Support; Dr. Marco Muñoz, evaluation specialist, Data Management, Planning, and Program Evaluation; Amy Dennes, assistant superintendent, Achievement Area 2; and Brad Weston, principal of Fairdale High School, provided an update concerning the telecommunication devices policy waiver pilot program for the 2013–14 school year. Each Board member had an opportunity to comment and ask questions.

Mr. Brady voiced his concern about the lack of a post-implementation review, an assessment of what went wrong and what went right, and various other data points. He noted that the specific lessons learned during the pilot program should be written down to provide a road map so other schools can benefit from the pilot schools' experience.

• Mrs. Duncan: "55,000 Degrees is an initiative that uses JCPS data to track our progress toward preparing kids for post-secondary study or education training. Our trajectory is reviewed to see if we are reaching goals. I would also like to—you know I think it's very important that 55,000 Degrees is also aligned with the jobs that we have coming into the community. So I would like to see the data that has been gathered on the jobs that have been created and what areas those jobs are in so that we can make sure our programs are aligned with the needs of the community and the jobs that are being created and brought in...I think we need to keep checking that alignment...and probably GLI has that information."
