Ms. Porter thanked the committee for their work, suggested the speaker's recommendations be incorporated into the committee's work, and requested that the Board receive an update after that occurs. Mr. Brady shared a summary of his research on grading scales used by other Kentucky school districts and proposed the use of a true ten-point grading scale. Dr. Willner asked the superintendent to comment on the equity issue and for her reassurance that the change will not cause more students to fail.
