VII.A. Report on National Assessment of Educational Progress Trial Urban District Assessment

Mr. Chris Harmer addressed the Board of Education concerning the NAEP TUDA.

Dr. Dena Dossett; chief of Data Management, Planning, and Program Evaluation; Suzanne Wright, director of Curriculum Management; and Tamera Lewis, data analyst; presented a report on the district's results from the 2015 administration of the National Assessment of Education Progress (NAEP) Trial Urban District Assessment (TUDA). Each Board member had an opportunity to ask questions and provide feedback.

Several Board members noted that the Board is currently discussing the possibility of reducing the number of assessments being administered and the need to have further conversations to discuss the value of this data and whether to continue participation. Chair Jones stated he feels there is value in statistical sampling and comparison data from urban districts of like size. Dr. Willner commented on the possibility of waiver requests to relieve the burden of mandated testing and noted that different tests serve different purposes.

IX. Board Reports, Requests, and Planning Calendar

Board members shared comments concerning school visits and activities; the Local Progress National Convening of elected school board members; School Psychology Awareness Week; Making the Connection; an event at Fairdale High School highlighting the AT&T It Can Wait texting and driving campaign; the American Cancer Society's Great American Smokeout; the 30th anniversary of the JCPS/YMCA Childcare Enrichment Program; the Prichard Committee for Academic Excellence; a collaboration with Uspiritus Bellewood; a community event with Louisville Metro Councilwoman Angela Leet; and a potluck supper with Board members, the superintendent, and their spouses. Chair Jones commented on the number of individual Board

requests made during tonight's meeting and reminded Board members of the special meeting with Dr. Thomas Alsbury on Wednesday, November 11, at 5:30 p.m.

Board members made the following requests:

- Mr. Haddaway repeated his previous requests for a report on teacher absenteeism rates for the past two years and an update on the supply of substitute teachers. In reference to the Comprehensive Annual Financial Report, he requested information concerning the percentage change in the number of teachers and whether the change is independent to the percentage change in the number of students as well as information on school building capacity to include how a school exceeds its building capacity and any data that shows the impact on student achievement.
- Dr. Willner requested information concerning the reclassification of Functionally Mentally Disabled classrooms to Moderate/Severe Disabilities and whether the reclassification was mandated by the state or Board policy as well as information on Student Response Teams to include when and why they were implemented, any data to show their effectiveness, and how SRTs compare to more proactive approaches. She also commented on mid-year teacher resignations and requested data regarding any exit interviews conducted.
- Mrs. Duncan requested information concerning 107 vacancies in schools and data that shows the district's response to students with behavior issues and emotional challenges.
- Mr. Brady also commented on teacher retention and stated that it would be beneficial for the district to conduct exit interviews to capture data concerning teacher retention and the reasons teachers leave the district.
- Mrs. Horne repeated her previous requests for an update on potential funding for the Museum School, information concerning interventions for Advance Program students who are not proficient or distinguished and individual learning plans for gifted and talented students—especially those who are not yet proficient or distinguished, and measurements of outcomes.

Mrs. Duncan requested that a report on the recent salary study be added to the planning calendar.
