IX. Board Reports, Requests, and Planning Calendar

Board members shared comments concerning school visits and various activities.

Mr. Brady shared a memorial service he attended with Chair Jones. He detailed an educational video created by Male High School Senior Hannah Gadd. The documentary called *Heroin: Drug of Sorrow,* was created to bring awareness to the growing epidemic of drug addiction. Mr. Brady encouraged high school principals to view the video so that they may share with students.

Mrs. Duncan attended the Who's Who Ceremony at Iroquois High School, describing it as a very moving experience full of diverse students. She also informed Board members that she recently joined the Louisville Out-of-School Time Coordination Council that will help plan out-of-school time programs for local students.

Ms. Porter took a moment to thank Board members for re-electing her as Vice-Chairwoman. She acknowledged the students from ESL Newcomer Academy for their presentation earlier in the meeting and welcomed them to return. Ms. Porter also expressed appreciation for Samuel "Sammy" Moore who had recently passed away. Sammy taught physical education for 33 years at Noe Middle School. He was a mentor, coach and father figure for many youths in the Louisville area.

Chair Jones conveyed his appreciation to Board members for re-electing him as Chairman. He reviewed some of the progress made from the previous year and expressed enthusiasm with the Board's pursuit for positive outcomes with the coming year.

Board members discussed the planning calendar.

Mrs. Horne asked for clarification on the January 26, 2016, Board meeting agenda. She had concerns regarding the draft budget and asked Board members if they would share their view concerning the topic.

Mr. Brady wanted to clarify the timeframe requirement regarding the approval for school allocation standards.
