Mrs. Horne requested a discussion of the consent calendar before taking action.

Mrs. Horne: "I noticed that on the consent calendar that Dr. Hargens is putting it forth. There have been several times when I've asked about it and you've replied (Dr. Hargens) that you can't know exactly what is being submitted, so I'm getting concerned that when we have items on the consent calendar, that you will stand behind them. That what is being submitted, that we should trust that what the notes for each of the items, that they are something that you will stand behind as being true."

Dr. Hargens: "Absolutely, the consent agenda has that the superintendent recommends. Each of the Chiefs submit items, and you will see on the bottom Submitted By, but absolutely I stand behind my team when we submit items."

Mrs. Horne wanted reassurance that she can trust the rationale for each agenda item and know that the language is true.

Dr. Hargens stated that general counsel reviewed the item that she is referring to and he did not find any problems with the language for the item.

Mrs. Horne explained that her concern comes from a previous item on September 13.

Mrs. Horne: "I am very concerned that what we are being asked to approve, is on the face what we are being asked to approve. I am getting more and more concerned and I need to be able to trust what is being provided to me as a Board member."

Mrs. Duncan stated that she supports all parts of the policy except the ability of a school to exit students; it is not consistent with Magnet Schools of America. Mrs. Duncan discussed the recent Local School Board Members Advisory Council Meeting and Southern High School graduate Lisa Harrison who was honored as a Hometown Hero.

Mrs. Horne stated that multiple principals were invited to attend a new budgeting process meeting that she wasn't aware of. She researched the board records in order to find the professional services contract and to find out how the board had hired a consultant that was coming into our schools. The problem is that the board didn't approve the contract, they approved a money donation from C.E. and S. Foundation through the Jefferson County Public Education Foundation. She doesn't have a problem with the substance of the contract, but she is very concerned about the way it transpired. This is a truthfulness issue and ethical dilemma.

Mr. Mellen stated that he reviewed the contract with Tom Hudson and he did not find any legal issues with the way that the contract was entered.

Mrs. Horne stated that she is also concerned that it is a conflict of interest to have general counsel advise both the Board and management. She sees it as a legal conflict and she is very concerned about the independence of our general counsel.

Mr. Mellen stated that he has already responded to Mrs. Horne's concerns regarding this issue and he will respond separately to all Board members.

Ms. Porter discussed a recent Fayette County Board of Education Planning Meeting that she and Dr. Hargens attended. She extended an invitation for the upcoming Facilities Committee Forum at Central High School on November 30. She concluded by announcing that the Louisville Defender Newspaper presented its Outstanding Professional Achievement Recognition Award to Dr. John Marshall.
