VI. Superintendent's Report

Superintendent Donna Hargens delivered remarks regarding: the Board's dashboard; *Louisville Linked*; Cabinet's Listen and Learn Session; *Vision 2020* Conversations; a Community Conversation at the Southwest Regional Library; the movie *Hidden Figures*; activities at the Kentucky Science Center; and the University of Louisville College of Arts and Sciences Yearlings Club Forum Series. She congratulated Chief Equity Officer Dr. John Marshall who was invited to serve as the keynote speaker for the Benjamin L. Hooks Institute for Social Change at the University of Memphis on African American Male Achievement. She concluded by thanking and recognizing the seven Jefferson County Board of Education Members as part of National School Board Recognition Month and recommended the consent agenda for approval later in the meeting.

VII. Action Items

VII.A. Review and Examination of the General Fund Draft Budget for Fiscal Year 2017-18 Chief Business Officer Tom Hudson; Chief Financial Officer Cordelia Hardin; and John Collopy, director, Financial Planning and Management, presented the rationale on this item. The report compared last year's actual revenues and expenditures and the current year revised budget figures with next year's projected budget. Each Board member had an opportunity to comment and ask questions.

Ms. Porter stated that it is important to hear the voice of our community and students; she requested to have conversations with schools in order to hear their needs. She wants to include student voice. She stated that it is the Board's responsibility to ensure that the money and resources are going where it is needed. She requested to see where the dollars are going as it pertains to the strategic plan.

Mr. Hudson advised the Board that funding only goes toward initiatives aligned with *Vision 2020*.

Mrs. Duncan requested to see the impact of Title 1 money, she expressed concern that the money does not follow Title 1 students to Non-Title 1 schools.

Dr. Kolb expressed concern with equity and allocations. He stated that they need to provide resources to help students that have the most barriers.

Dr. Willner requested to have the presentation from the September 13, 2016, budget work session be provided to all Board members since some were not present at that time. She advised that all budget requests should be reviewed to ensure alignment with the strategic plan and also with a high rating from the Program Evaluation Department. She expressed concern regarding the continuation of funding to programs that have not proven to be effective. She requested a report regarding where we are with those evaluations.

Mr. Gies echoed Dr. Willner's request regarding data from program evaluation. Mr. Hudson stated that he would provide the data showing the success ratings on programs in the district.

Mrs. Horne expressed concerns. She stated that the allocations do not look at student needs and she is still very concerned with the lack of support in the district for Arts and Music instruction. She stated that there are too many issues that add up and make it hard for her to support allocating so many students to schools that are over optimal capacity. The budget needs to serve students better. She is encouraged with the people getting involved to help and she is going to do her best to help create positive change.

Chair Brady stated that he is encouraged to know that there is going to be more program review. He expressed concern regarding a lack of cross-functional integration with Facilities and Finance.

Mr. Hudson stated that the Facilities Study will address Mr. Brady's concern and pull it all together in a comprehensive way.

VII.B. Approval of Student Enrollment Projections for 2017–18

Dr. Hargens introduced this item and Chief of Data Management, Planning, and Program Evaluation Dr. Dena Dossett; Barbara Dempsey, director, Student Assignment; and Ralph Stephens, demographics analyst, presented the rationale. Each Board member had an opportunity to comment and ask questions.

Mr. Gies expressed concern regarding class size and requested a report detailing current class size numbers.

Mrs. Horne expressed concern regarding teachers that must work on carts and classrooms being held on stages. She feels like this is the same formula and budget situation as last year and we are in the same situation. She will continue to vote no on this. She discussed the capacity at Crosby Middle School and she stated that she is happy to see that the district, through a lot of hard work and a facilities study, is getting to an optimal capacity.

Dr. Willner stated that she is going to vote against this and explained her reasoning. She would like to see systemic work and conversations with the community to understand how student assignment changes may impact choices that parents make. We have had the Facilities Study for several months, and she feels it's a problem when she sees the number of schools over building capacity and the impact that that has, particularly at the middle school level. She expressed appreciation for comments regarding the need for systemic conversations and systemic work, but she would have liked to hear that those conversations were already well underway before being asked to vote on this.

Dr. Kolb requested to see the optimal capacity numbers for all schools.

Chair Brady stated that he feels there is a lack of cross-functional integration with this item too.

Chair Brady and Mr. Gies both expressed a desire for smaller class sizes.
