Dr. Pollio introduced this item. Chief of Data Management, Planning and Program Evaluation Dena Dossett; Barbara Dempsey, director of Student Assignment; and Ralph Stephens, demographic analyst, presented the information. Each Board member had an opportunity to comment and ask questions.

Mrs. Horne expressed concern with the abundance of new construction in District 3 since most schools are at 90 - 100 percent capacity. She voiced disappointment that the District uses program capacity instead of optimal capacity. She stated that she is excited about the Student Assignment and Facilities Committees and she fully supports the movement to make things better.

Dr. Willner and Mr. Brady shared Mrs. Horne's concerns.

Dr. Pollio stated that he understands the concerns; this will be a multiyear process to correct the issues.

Mr. Brady also expressed concern with inadequate funding to address the needs.

X.C. Acceptance of General Fund Draft Budget for Fiscal Year 2018-19

Dr. Pollio introduced this item, Ms. Hardin and Mr. Collopy presented the General Fund Draft Budget. Each Board member had an opportunity to comment and ask questions.

Dr. Pollio reiterated that this is only a draft, there are still a lot of unknowns and uncertainties.

Multiple Board members expressed concern with the impact of potential changes in the state's budget. Dr. Pollio stated that he has visited Frankfort numerous times to discuss how the proposed cuts could impact the District.

Mrs. Horne requested to see the increased dollar amount of projected revenue since it ended up being higher than originally expected in the Working Budget. Mr. Collopy stated that they projected three percent but it actually came closer to four percent, he said he would provide the dollar amount to her.

Mr. Brady requested confirmation that the state cannot mandate budget cuts by the District. Mr. Mellen agreed with Mr. Brady's comment and stated that the District is an independent legal entity. Dr. Kolb questioned if the state's recommendation for transportation reduction is our biggest concern. Ms. Harden confirmed that the biggest concerns are the possible reductions in transportation and the recommended 12 percent administration cut.
