VI. Superintendent's Report

Dr. Pollio provided the Board with an update on the progress of major change initiatives. He stated that he hopes to receive the reorganization report from the Council of Great City Schools by the end of the week. The first of several organizational chart changes will be presented at the March 27 meeting. This will be the most substantial reorganization that this district has seen in many years. He then discussed the revamping of *Vision 2020* which will provide a focus on what the District plans to do and accomplish by December 2020. He continued his report by discussing upcoming facility changes, MAP, and the District-wide backpack of skills. He concluded by announcing a new task force to reimagine and reshape the District's alternative school programs.

X.A. Review of Charter School Policies

Dr. Pollio introduced this item and Cassie Blausey, director of school choice, presented the policies that will set forth parameters for the charter school contracting, monitoring and evaluation, transparency, finances, renewal, revocation, and closure. Each Board member had an opportunity to comment and ask clarifying questions.

Ms. Blausey stated that she hopes to create a process that is so quality-driven that applicants won't waste their time applying if they do not meet the high standards of the Board. She expects to set high expectations which will make the District renowned for only approving high-quality charter schools. She plans to clearly articulate needs and exactly what the District is looking for within the performance framework, throughout the contract, and throughout the application process.

Multiple Board members expressed concern that the expectations are not reflected in the language of the recommended policies that are on tonight's consent agenda.

Dr. Willner stated that if the reason for having charter schools is because the District is not meeting a specific need, then we should include explicit language in the policies about the needs and what the Board will require of charter schools before granting authorization.

Dr. Kolb stated that he hopes to set the bar really high in every charter document that the Board passes. The Board should not take the time to review an application in detail unless there's a compelling reason to do so, and there's not a compelling reason to do so unless you can go above and beyond what the District is already doing.

Ms. Blausey stated that she will look into addressing the concerns with the policy language.
