Mr. Brady expressed concern with language in the revised policy which seems to indicate we are expanding alternative schools to include elementary. He explained that the policy is required to cover both A5 and A6 schools and many A6 schools serve elementary-aged students. He requested clarity in the language before the second reading is presented to the Board.
