Due to the reduction in meeting room capacity due to COVID social distancing requirements, and recognizing many members of our community were not yet ready to attend in-person public meetings, in-person comments to the Board were deferred. VIII. Action Items

A. Recommendation for Approval of Student Support and Behavior Intervention Handbook Revisions and The Student Bill of Rights

Board members received a brief presentation summarizing the rationale for the recommended revisions. They each had an opportunity to ask clarifying questions and express concerns.

Mrs. Duncan said, "I've asked questions along the way and I've just not felt comfortable with the responses so I probably will not support these changes." She briefly discuss language that she said is troubling to her and questioned race conscious supports and interventions to reduce disproportionate outcomes; data on restorative practice showing it reduces recidivism/repeat offenses; and no suspension for kindergarten through third-grade. She also questioned funding for these kinds of treatments.

Board members received a brief presentation summarizing the recommended Tentative Budget. They each had an opportunity to ask clarifying questions.

Chair Porter asked for a list of what funding looks like for individual schools.

Mrs. Duncan expressed concern that they are not budgeting and planning for potential threats and said, "I just want to say that I'm afraid this budget doesn't make me feel better about keeping our kids safe in our schools with what we've added. We've added five security monitors and one security officer and we have seen a proliferation of guns in this community."

Dr. Kolb reiterated a few items in the budget and acknowledged that we are seeing more and more need and less and less funding. He asked for clarification on page 31 regarding the SEEK formula. He asked if the District has had conversations with State legislators regarding funding for state agency schools.

Good evening.

My name is Mike Beard and I am a teacher at Iroquois High School. I am here tonight to talk about school safety.

In August of 2019, just a couple of weeks before school began, and while the board was short one member, due to a resignation, three members of this board, with very little if even any public notice, voted to not renew the contracts of several police departments' that had been working in our schools for many years.

After hearing the concerns of parents, the general public, faculty and staff, plans were announced that some officers would be back in some of the schools by February of 2020. In the meantime the district would work on a plan to have its own internal police force. No officers were ever placed back into any schools and the plans for the JCPS security force is still waiting for the final approval of this board, even after there have been numerous meeting and adjustments to the Standard Operating Procedures Manual.

During that time with no officers in our schools, let's review what took place in our district.

*9 And let's not forget what happen just a couple of months ago just as we returned to in person learning, when a man, armed with a gun, tried to enter Greenwood Elementary. It was reported he even tried to drive his vehicle through the cafeteria doors. Who could have confronted him if he were able to get into the building?

Fortunately, no one was hurt or killed as a result of these weapons being at schools. But do you really think these were the only weapons brought into our building and on our properties during the school year? And how much longer do you think we will be so fortunate, before something tragic happens in one of our schools?

In March of 2019, Senate Bill 1 was signed into law, requiring among other things that all schools have an SRO. This bill was a direct result of the horrific school shooting in January of 2018 at Marshall County High School in which, two students, Preston Cope and Bailey Holt,

both just 15 years old, were killed and 14 other students were wounded. This Board has chosen not to comply with this law.

In February of 2020, Senate Bill 8 was signed into law, requiring among other things, that SRO's must carry a firearm. This bill was a direct result of members of this Board implying that they might follow the directive in Senate Bill 1, to have officers in the schools, but to not allow them to be armed. This Board has also chosen not to comply with this law.

Just a point of interest for the newest member of the Board, and a reminder to the other members. A survey was sent to all middle and high school staffs, seeking their opinion on this very subject. Over 2500 people responded and the results were overwhelming in support of armed officers in our schools.

90% responded yes, they want an officer in their building and 82% said they want that officer to be armed.

So at this time I am asking that all members of this Board go on the record publicly and say if they will continue to ignore and not comply with state law, or will they do the right thing, follow the law and support having armed officers in our building for the start of the 2021-22 school year. If it's about the funding, just how much is too much to spend for the safety of our students and staff?

Dear Chairwoman Porter, Board Members, and Superintendent Polio,

JackBeNimble, Inc. (JBN) is a Jefferson County based, non-profit and nonpartisan network of students with disabilities, their families, allies, and providers. We seek to work in collaboration with educators and policymakers to improve the special education system for all involved, most importantly, for the students themselves.

I write to you regarding the following items on today's Board Meeting agenda:

- Item # VIII.A. Recommendation for Approval of Student Support and Behavior Intervention Handbook Revisions and The Student Bill of Rights
 - Although the 2020-2021 SSBIH Revision Process included two ECE teachers, we understand that few students with disabilities or their family members, allies, or providers had an opportunity to participate. The 13,736¹ JCPS students with IEPs are among the subpopulations who disproportionately receive consequences such as restraint and seclusion. We urge the Board *not* to adopt this Handbook until a more thorough and inclusive discussion of how students with disabilities are impacted by these policies takes place.
 - We strongly recommend that the JCPS ECE Advisory Council should be included in the review process.
- VIII.B. Recommendation for Approval of Tentative Budget for Fiscal Year 2021-2022
 Page 17 of the *Tentative Budget* document (see Agenda for today's meeting) references
 that over \$10 million is being invested in Exceptional Child Education (ECE)
 Implementation Coaches, "positions that will support the schools with compliant
 implementation of federal guidelines under the Individuals with Disabilities Education Act
 (IDEA)."

While we appreciate the consideration of students with disabilities, we urge this Board to:

1. Develop and adopt a "Disability Equity" policy comparable to the Racial Equity policy before the beginning of the next school year.

- 2. In lieu of or in addition to the Implementation Coach positions, invest substantially in enhanced professional development for all staff, including general education teachers and paraprofessionals to ensure that students with disabilities are receiving equitable access to and quality instruction in the general education curriculum. As presently stated, the focus of the Implementation Coach is on compliance with federal and state law. Compliance should be the expectation, not the destination.
- 3. Evaluate the investment of \$10 million in light of the mandate of Congress and President Biden under the American Recovery Plan to "expand opportunities for students who need the funds most, including students from low-income backgrounds, students of color, students with disabilities, English learners, students experiencing homelessness, and students with inadequate access to technology."²
- 4. Heavily invest also in eliminating longstanding inequities for students with disabilities, including students with section 504 plans. Such inequities may include: inaccessible activity buses (or unavailable), inaccessible playground equipment, exclusion from extracurricular activities, segregation during the school day. "It is particularly important that ARP ESSER funding will enable States and school districts, as well as schools, to support students who have been most severely impacted by the pandemic and are likely to have suffered the most because of longstanding inequities in our communities and schools."
- X.C.2. Recommendation for Approval of Job Descriptions Human Resources
 Ensure that all current and new "Transition Teachers" (Emergency Certified
 Substitute Teacher) receive special education training to enable them to be
 qualified to substitute for special education teachers, when necessary.
- X.K.1. Recommendation for Approval of Memorandum of Agreement with Jefferson Community & Technical College for Dual Credit Courses
 Section IV on page 2 of the MOA does not specify whether students with IEPs taking courses "at JCTC" will receive their documented IEP services. Please clarify what JCPS' policy is with respect to these students. Will they or will they not continue to have their IEP implemented when taking a course on the campus of JCTC? Would their IEP be implemented for all courses except the JCTC course? What specifically and exactly is JCPS' policy?
- X.M. Adoption of Board Policies 08.1348 Certified Oral and Written Language Support, 09.4341 Alternative Education Programs, and Board Policies Relating to the Student Support and Behavior Intervention Handbook (First Reading)
 - Page 6 notes that placement in an alternative education program may be voluntary. Yet, page 7 under "Exceptions" notes that for students with disabilities, decisions are made by either the ARC or Section 504 team.
 Surely, students with disabilities are entitled to access the full range of

- Please also see comments under the first bullet, Item # VIII.A. We urge the Board **not** to adopt these policy changes until a more thorough and inclusive discussion of how students with disabilities are impacted by these policies takes place.
- We strongly recommend that the JCPS ECE Advisory Council should be included in the review process.
- X.O. Recommendation for Approval of Supplemental School Year Program Requests We urge the Board to vote "yes" to permit supplemental school year program requests for any family making such a request. Many students with disabilities have been significantly impacted by the pandemic. Some of these families feel their student(s) would benefit from a supplemental school year. They should be given this choice.
