Dear School Board Members,

Hello. My name is Benjamin Bush, and I am a teacher at Marion C. Moore School. I have been a teacher at Moore for 10 years. I love what I do, I love where I teach, and I love the people that I work with. I believe that the administrators, teachers, and staff at my school are hard working, talented, and well-intentioned.

Marion C. Moore is a school that is 87% free and reduced lunch, 36% black, 22%, hispanic or Latino, 34% white, and has a wonderfully diverse and ever-growing ELL population. Yet there is one number that has made, and will continue to make, all of our efforts remarkably daunting. It is not our poverty rate or our test scores. No, it is the fact that our school is wildly overcrowded. It has been for a few years now. Our school sits at 136% capacity for the 2021-2022 school year. 136% means that when we return to full in-person school next August, our school will host 36 percent more students than we can reasonably hold.

On the page, this number must sound abstract. To me, and to the people I work with, it is concrete. This number affects every decision we make as a school. It lurks in the background of every plan we consider. It makes everything that we do harder.

136% means that there will be 15 teachers on carts next year. That means 15 teachers who do not have a permanent home in the building. 15 teachers who are traveling from class to class each and every period, each and every day. This directly impacts the ability of these teachers to effectively educate students. Every class and every student that is taught by a teacher on a cart begins at a distinct disadvantage.

136% means that almost no teacher is able to use their own classroom during their planning period. We are spread throughout the building scrambling to find a quiet room in which to work.

136% takes a toll on the mental health of our students, faculty, and staff. It is always loud. It is always crowded. I have anxiety during every class change as the crowd of students moving between classes bottlenecks around my room down the stairwell to the first floor. I know that all it would take is one fight at exactly the right moment to cause people to be trampled.

136% will also have a profound effect on the physical health of the students and staff at Moore. If we return, as expected, to school in the fall with no masks, a complete inability to social distance, and no mandate to require a vaccination, coronavirus will spread in our building.

136% capacity means that the caseload of every teacher, counselor, assistant principal, social worker, therapist, cafeteria worker, security guard, and clerk in the building is consistently maxed out. Our class sizes are maddeningly large. As a building we dole out over \$2300 a day in overcap pay related to class size. This translates into 1,211 times *every day* in our building that there are more students than are contractually allowed in classrooms. Teachers routinely have 35 students or more in a class. Though I hope that you are familiar with research related to

class size and its effect on learning, I am going to link some examples <u>here</u>, <u>here</u>, and <u>here</u>. There are few more settled research points in education. Class size matters.

136% is sabotaging everything that we do at Moore. No initiative or program at the classroom, department, academy, or school wide level can avoid addressing the cascading effects of our ballooning class size and population issues. There is no break in the day for teachers or students. Every class is maxed out and our students suffer because teachers cannot give them the personalized attention that they need. It is so much easier for a student's mental health, academic standing, and general well being to fall through the cracks. It is simply too crowded to notice everyone, which means many of our students feel invisible.

136% means that APs and counselors spend their days putting out fires: fights, classroom disruptions, mental health breakdowns, panic attacks. 136% exacerbates these problems. Not only because there are more teenagers processing the complex issue of growing up, but because we are throwing so many of them together in such close proximity, many otherwise manageable situations become unmanageable.

136% means our kids literally do not have enough time to eat. The line to get lunch often does not clear until there are only five minutes left until the bell rings to return to class. This is not the fault of our amazing cafeteria staff. They just don't have the time, staffing, or space to feed the students assigned to our building in an efficient manner.

136% means there is no space. For anything. We have cordoned off sections of the Library into classrooms. We are using former broom closets as offices. The teacher's lounge was removed due to a lack of space a few years back. Teachers have had to teach classes from makeshift classrooms in hallways, or crowded in the back of the Library.

136% means that I will continue to watch talented teachers, who I respect, put their names on the transfer list because they cannot cope with 5 classes of 30 plus students day in and day out. It means that the talent drip of teachers out of this building becomes even more pronounced. 136% in the 2021-2022 school year will mean burnout for far too many of my colleagues.

136% means that we are thinking about using our extra stimulus money to bring in trailers to house the students that just don't fit in our building. The message this sends to our students about how they are valued is stark.

136% is remarkably frustrating though because there are high schools like Jeffersontown, Iroquois, and Shawnee that sit at 50 percent or below capacity. This ranckles more than anything. Schools are sitting half-empty, while we consider teaching our students in a trailer.

Members of the school board you have the power to fix this. This is within your control. I, and all of the students, teachers, administrators and staff at Moore implore you. Adjust the student assignment plan. Move students to schools where space exists.
