Dr. Pollio thanked JCPS staff for all their hard work as he recognized the many accomplishments and challenges from the past school year.

VIII. Action Items

A. Recommendation for Approval of Tentative Budget for Fiscal Year 2022-2023

Chief Financial Officer Cordelia Hardin presented the rationale for the Tentative Budget. Each Board member had an opportunity to comment and ask questions.

Mr. Craig asked how much is allocated in this budget for staff raises; he specifically questioned salaries for mental health professionals. He then stated, "I want to express here, as we address the budget, that in my view, 1.5 percent is wholly inadequate for the District and its current staff going forward." He concluded by requesting more information at a future work session or a Board meeting about middle school pathways.

Mr. Marshall asked about the future of Pathfinder for elementary and said, "...as we're talking about this tentative budget, I don't know if we've budgeted for the possibility that we might look into submitting that waiver paperwork. So where are we at with those discussions and funding for next year?"

Mrs. Duncan wanted to know the total amount saved in escrow from the extra tax that was collected for the past two years.

Ms. McIntosh questioned how the rising fuel costs would affect the budget. She then said, "I echo Board member Craig's sentiments around salaries and I want to make sure that JCPS is, as an employer, a competitive, highly attractive place to work and that we are valuing our employees both with our actions and our words."

Chair Porter questioned funding for Elev8 Learning Centers. She then went on to say, "I would like to hear you say that the dollars are there for the additional staff that we will be hiring as it pertains to the school's safety plans or anything else that Dr. Pollio is presenting. Is the money there?"

IX. Information Items

A. School Choice Proposal

Dr. Pollio presented the recommendation and began by saying, "At this time, we wanted to take stock of where we are on the school choice recommendations. We have been on a long journey through this. I think we really started intensely talking about this in December. So for the better part of five or six months, we've been working on this. I clearly understand why no superintendent or board has chosen to tackle this in 40 years because of the challenge that comes with it and really educating and getting buy-in and agreement on how to move forward. I do believe we have really scoured the community as much as we possibly can -meeting with as many people as we possibly can over the past three months in order to make some changes. Tonight, I'll be highlighting some of the changes that we made to the plan."

Each Board member had an opportunity to comment and ask questions.

Mrs. Duncan asked, "Are we following a model that anyone else has produced so that we have a kind of blueprint to help us make this determination, or is there a similar model out there that we're following?" She then asked, "What are we going to call our schools that still have criteria for selection of students because we can't call them magnets? Do we have a name for them?" She asked about continuing with instructional assistants in elementary classrooms.

Ms. McIntosh said, "I want to thank all of the JCPS staff and everyone for all that they're doing and I just hope that our community and state leaders will take notice of the hard work we are doing and lead their organizations and entities to do the same."

Mr. Marshall questioned the changes at Western High School. He asked about school-initiated exits and the impact that may have on traditional programs. He concluded by saying, "With our schools that will still allow criteria, it's my hope that as we continue to try to align better with MSA, that we do look into putting every one of our magnets on an even playing field whether that be criteria for everyone or as MSA recommends, a lottery-based system for everyone."

Dr. Shull discussed the importance of community input. He then went on to say, "I want to ask a couple of questions concerning the \$12 million investment and the multiple opportunities that schools will have to choose from. Could you give an overview of what opportunities specifically will be on the docket for schools to choose from for those funds?"

Chair Porter wanted clarification regarding school-initiated exits and the effects of renaming John. F Kennedy Montessori Elementary School and Shelby Traditional Academy. She then asked Dr. Pollio to present to the Board and community what staffing looks like quarterly so they know how schools are staffed. She wanted clarification regarding how the schools in the Choice Zone would be staffed.
