VI. Superintendent's Report

Dr. Pollio discussed a major change initiative coming to JCPS in the next several months. He stated that he plans to present specific recommendations regarding start times for schools. He announced that he will be sharing more information with schools, families, and the community in the next few weeks.

VIII. Action Items

Cordelia Hardin, Chief Financial Officer; Thomas Aberli, Executive Administrator of Budget; and Brent West, Manager of Geographic Information Systems; delivered a presentation regarding School Allocations, Enrollment Projections, and the Draft Budget. Each Board member had an opportunity to ask questions.

Mr. Marshall wanted to hear more about per pupil investment numbers and how that data can help plan the Budget.

Mrs. Duncan questioned how the English Learner (EL) population increase affects enrollment projections and how impactful the funding formula would be on equity.

Mr. Craig requested more information regarding the Draft Budget including a comparison between the projected amounts with the current numbers. He asked about school budgets and requested a spreadsheet showing the new classifications.

Ms. McIntosh questioned the possibility of fluctuation in school categories – Tier I, II, III, and IV. She requested more information regarding the Exceptional Child Education (ECE) Needs Index with Gifted and Talented.

Dr. Kolb asked what "Mobility" means in the Middle & High Staffing Formula - Student Needs Index.

Dr. Shull questioned continued funding for the Elev8 Student Learning Centers once the Elementary and Secondary School Emergency Relief Fund (ESSER) is no longer available.

Chair Porter questioned the funding process if student enrollment numbers dramatically change. She asked about funding for schools as the English Learner population continues to increase. She then wanted clarification regarding staffing when there are changes in the placement of Exceptional Child Education (ECE) students.

Mrs. Duncan expressed concern about the low percentage that is attached to EL Needs Index.

Chair Porter requested a June update on the Student Enrollment Projections.

Amanda Averette-Bush, Executive Administrator of School Choice; Jamiera Johnson, Director of Choice Zone; Dr. Jeronda Majors, Principal; and Kym Rice, Principal; presented the update. Each Board member had an opportunity to comment and ask questions.

Mr. Marshall asked if there is still a plan to have "Executive Principals" in the Choice Zone. He then shared a concern that he has received regarding Western High School not having a freshman class next year. He said, "Athletics had a lot of concerns because it's going to put them back a whole entire class as far as athletic development." He then requested the final list of magnets for the 2023-2024 school year.

Mrs. Duncan asked about enrollment numbers and if there is a limit to the number of applications that would be accepted.

Mr. Craig requested a follow-up on enrollment numbers and the impact on other schools.

Ms. McIntosh asked if the District is tracking data regarding which programs high school students from the Choice Zone are selecting - whether they choose to stay close to home or far away.

Chair Porter wanted to ensure that every student in the Choice Zone would be enrolled in Early Childhood and is prepared for Kindergarten. She wanted to hear more information regarding the decrease in magnet schools in the Choice Zone, specifically the Montessori Program.
