VI. Superintendent's Report

Chief of Staff Dr. Katy DeFerrari provided the Superintendent's Report. She began with a message from Dr. Pollio, "He very much appreciates the outpouring of support, not only from Board members, but staff, community members, and our students as he recovers from his emergency back surgery." She then announced that Dr. Pollio had been awarded the Charles Bowser Award for Innovation in Education at the National Career Academy Coalition Conference. She provided a brief update regarding the assessment of the Transportation Department and the transportation activities of August 9, 2023; a swatting situation at two JCPS schools; the new weapons detection systems; and the recent Board Retreat.

Acting Chair Shull extended warm well-wishes to Dr. Pollio and hopes for a speedy recovery.

Ms. McIntosh requested information/results on A5 Alternative Education Programs.

Mrs. Duncan wanted to better understand the state accountability scoring system. She stated that she had trouble following the data. She wanted to clarify the information for African American students.

Mr. Craig stated, "The results are commendable for the District, but I'll repeat again my general skepticism of the value of making budgeting and high-stakes policy decisions based on high-stakes testing and accountability metrics."

B. Acceptance of Updates on Alternative and Specialized Option Schools

Dr. DeFerrari introduced this item. The update was presented by the following staff members: Heather Benfield, executive administrator, high schools; Dr. Joe Ellison, assistant superintendent, high schools; Dr. Rob Fulk, interim chief operations officer; and Robert Moore, chief of schools. Each Board member had an opportunity to comment and ask questions.

Ms. McIntosh asked for clarification on A6 Alternative Education Programs. She questioned state accountability assessments for out-of-district state agency children; state funding for those students; and the enrollment/services availability in these programs. She asked if the State provides any additional funding to districts for A5 programs.

Mrs. Duncan wanted clarification on A5 schools Grace James Academy of Excellence and W.E.B. DuBois Academy. She then asked for more information regarding Career Pathways. She suggested they consider a bigger building for Newcomer Academy as the Multilingual Learner population grows. She expressed concern about transportation issues and questioned the need to replicate The Phoenix School of Discovery on the other end of town.

Mr. Craig praised The Phoenix School of Discovery and agreed that there is a need to expand those opportunities throughout the District.

Acting Chair Shull asked if staff at A5 schools are eligible for hazard pay. He then asked, "Can you articulate the distinguishing characteristics between Minor Daniels and Breckinridge Metro?" He questioned the exit process/communication at these schools. He then asked, "How are we ensuring that students who end up in one of the alternative schools and need to be separated from one another, how are we ensuring that takes place?" He concluded by expressing concern with transportation and wanted to ensure that, as issues arise in the District, these schools are not automatically the first to be bumped to the bottom to have bus routes dropped.

Mr. Craig shared the transportation concerns and advised that the District needs to communicate with these schools because they are of the opinion that because of the size of the school and because of the status of the school, they are not being treated fairly with transportation.

Dr. DeFerrari introduced this item and Chuck Truesdell, executive administrator, Government and Community Relations; presented the draft Legislative Agenda. Each Board member had an opportunity to comment and ask questions.

Mrs. Duncan said, "I'd like for us to think about the funding formula for our multilingual students and what we can do to increase that funding to support that growing population." She then stated that she didn't think that Pre-K could be fully utilized unless we had some kind of universal attendance requirement. She expressed the need to have more flexibility with NTI days. She then asked if gas cards would be included with funding.

Dr. Kolb acknowledged the Board's key issues revolve around funding. He wanted to ensure that is the clear top priority.

Ms. McIntosh agreed that the key issues revolve around funding. She said that transportation and add-ons are the biggest pieces for her. She emphasized the importance of equitable access to necessary curriculum, supports, and resources.

Mr. Marshall stated that he agreed with all the points that had been made, especially funding.
